	Certificate of Approval MHC 93/19 was issued in 2019 authorizing changes to Victor Steinbrueck Park. A condition placed on MHC 93/19 required that if the park's totem poles were removed during the park renovation, that they must be reinstalled prior to the reopening of the park. Certificate of Approval MHC 37/25 was issued in 2025, amending MHC 93/19 to temporarily allow the park to reopen prior to the reinstallation of the totem poles. The temporary approval outlined in MHC 37/25 will expire on March 12, 2026. The commission will review DONH-COA-01146 and will potentially take action on amending or modifying MHC 37/25.
